In the County Court of Choctaw County, Okla.

In the matter of the estate of Silvey Billis, deceased.

ORDER.

Now on this the 11th day of August, 1908, comes D. C. McClure, Sissie McClure, Marful Thompson, Jinsie Thompson and Eliza Loring and files and presents to the Court petition praying for an order of the Court approving and confirming a certain deed of conveyance executed by D. C. McClure, Sissy McClure, Marful Thompson, Jinsie Thompson and Eliza Loring to S. H. Downing and V. Bronaugh, on the 10 day of August, 1908, to the following described estate, to-wit:

W/2 of the SW/4 of the NE/4 and SE/4 of NW/4 and E/2 of SW/4 of NW/4 and NW/4 of SW/4 of NW/4 and E/2 of NE/4 of SW/4 and W/2 of NW/4 of SE/4 all in Section 10, twp. 5 South, of Range Two W.

And the Court upon consideration of said petition being well and sufficiently advised in the premises finds; that Silvey Billis, a full blood Choctaw Indian was a resident of that portion of the Central District of the Indian Territory now comprising Choctaw County, State of Oklahoma, and on the 23rd day of February, 1906, died seized of the lands above described, which said lands were allotted to her by the Choctaw and Chickasaw Nations and conveyed to her under allotment as surplus and homestead patents, and that the said Silvey Billis was at the time of her death the owner in fee simple of the said lands; the Court further finds that the said petitioner, D. C. McClure, Sissy McClure, Marful Thompson, and Jinsie Thompson, are full blood Choctaw Indians, and that Eliza Loring is a 3/4 blood Indian, and are the only surviving heirs at law of the said Silvey Billis, deceased. That said petitioners, D. C. McClure, Sissy McClure, Marful Thompson, Jinsie Thompson and Eliza Loring on the 10th day of August, 1908, executed to S. H. Downing and V. Bronaugh for and in consideration of the sum of Four Hundred and Fifty Dollars, a warranty deed for the said described real estate.

The Court further finds that the said deed was duly signed and acknowledged by the said D. C. McClure, Sissy McClure, Marful Thompson, Jinsie Thompson, and Eliza Loring, and that the said consideration for the said deed is fully paid and that the same is reasonable, adequate and satisfactory to the said petitioners, D. C. McClure, Sissy McClure, Marful Thompson, Jinsie Thompson and Eliza Loring, and the Court finds that the said conveyance of the said real estate to the said S. H. Downing and V. Bronaugh should be in all things approved and confirmed.

It is therefore by the Court considered, ordered and adjudged and decreed that the said conveyance to the said above described lands by warranty deed dated August 10th, 1908, from the said D. C. McClure, Sissy McClure, Marful Thompson, Jinsie Thompson and Eliza Loring to the said S. H. Downing and V. Bronaugh be and the same is hereby approved and confirmed and declared legal and valid.
