STATE OF OKLAHOMA) ORDER FOR APPROVAL OF DEED IN CAUSE OF GILBERT COUNTY OF CHOCTAW) SS CHRISTIE AND ILLIE THOMPSON.

IN THE COUNTY COURT.

On this the 31st day of August, 1908, this cause coming on to be heard and all the parties interested in the petition herein filed being in court the Court finds from the petition herein filed and from the testimony herein taken that Emiline Christie died intestate in January, 1907, and was at the time of her death a citizen of what is now Choctaw county, Oklahoma, and seized in fee of the following described estate of inheritance, by reason of her rights as a full-blood Choctaw Indian;

NW/4 of SE/4 and W/2 of NE/4 of SE/4 and S/2 of SE/4 all of Section 14, Twp 6 South and Range 20 east, same being the homestead allotment of Emiline Christie, and S/2 of S/2 of NW/4; N/2 of NE/4 of SW/4 and NW/4 of SW/4 all in Section 17, Twp 8 North, and Range 6 West. containing one hundred acres, same being the surplus lands of Emiline Christie, deceased.

The Court further finds from the petition herein filed and the testimony taken that Gilbert Christie is a full-blood Choctaw Indian, twenty-one years of age, a citizen of Choctaw county, Oklahoma, and the only surviving parent of Emiline Christie, deceased, and that Illie Thompson is a full-blood Choctaw Indian, twenty-one years of age, a citizen of Choctaw county, Oklahoma, and a half sister of Emiline Christie, deceased, and that the said Gilbert Christie and the said Illie Thompson are the only heirs at law of the said Emiline Christie, deceased; the Court further finds from the petition herein filed and from the testimony taken that the said Gilbert Christie and Illie Thompson did on the 28th day of July, 1908, as the sole heirs at law of Emiline Christie, deceased, execute and deliver to W. E. B. Leonard a warranty deed to the surplus allotment of Emiline Christie as heretofore described for the purpose and consideration described in said deed, and that on the same day the said Gilbert Christie and said Illie Thompson, as the sole heirs at law of Emiline Christie, deceased, execute and deliver to Palmira Polly a warranty deed to that portion of the homestead allotment of Emiline Christie, deceased, as heretofore described for the purposes and consideration set forth in said deed.

The Court further finds from the petition herein filed and from the testimony taken, that the consideration paid for the respective lands by said purchasers to be fair, just and adequate and in all particulars satisfactory to grantors and grantees.

It is therefore ordered, adjudged and decreed, by this Court that said deeds be and are hereby approved .
