

IN THE COUNTY COURT OF CHOCTAW COUNTY, OKLAHOMA.

In the matter of the estate of Marful Thompson, deceased.

ORDER CONFIRMING SALE.

Now on this 18th day of Dec., A. D., 1908, comes on to be heard the petition of Sissy McClure, nee Thompson, Jincy Thompson, and D. C. McClure all full blood Choctaw Indians, in which it is set forth and alleged that Marful Thompson was a full blood Choctaw Indian, and duly enrolled on the Approved Tribal Roll, as of number 11,398, and that as such member of the Choctaw Tribe of Indians there was allotted to him the following described land, situate in Choctaw County, Oklahoma, to-wit:

SE/4 of SE/4 of NE/4, and the E/2 of the SE/4 and the SE/4 of the SW/4 of the SE/4 of Sec. 10, Twp. 5 South, R. 13 East,

Also the following described land situated in Leflore County, Oklahoma, to-wit:

The N/2 of Sec. 20, and the NE/4 of Sec. 19, and the W/2 of the SE/4 of Sec. 18, Twp. 7 N., R. 24 E., and the SE/4 of the SE/4 of Sec. 23, and the E/2 of the SE/4 of the NW/4 and the SW/4 of the SE/4 of the NW/4 of Sec. 26, and the SW/4 of the SW/4 of the SE/4 of Sec. 13, Twp. 7 N. Range 25, E., and the NE/4 of the NE/4 of Sec. 31, Twp. 8 N. R. 26 East.

That the said Marful Thompson died intestate on or about the 1st day of December, 1908, in Choctaw County, Okla. aged 22 years. That at the time of the death of the said Marful Thompson, he was unmarried, and never had been married, and left no children, neither father or mother, or no brothers, his only heirs at law being his two sisters, and the only sisters he ever had, to-wit: Petitioner Sissy McClure, the wife of petitioner D. C. McClure and petitioner Jincy Thompson. That on the 15th day of Dec., 1908, petitioners executed a Warranty Deed, whereby they conveyed all their right, title and interest in fee simple, unto V. Bronaugh in and to the lands hereinbefore described, for the consideration of \$1050.00, which they state they have received in full on said date, and ask that the same be approved and that this court has jurisdiction ~~xxx~~ to hear said matter.

WHEREFORE, the Court having heard the testimony, and being fully advised of the transaction finds: That all of said petitioners are full blood Choctaw Indians and of lawful age; that they lawfully inherit the lands that were allotted to the said Marful Thompson as set out in said petition; that the said Warranty Deed, as above set forth, was exhibited to the Court, and is in proper form and executed under the laws for such conveyances made and provided. The Court further finds that said deed was made for an adequate consideration, free from fraud, duress or undue influence, and that it is the desire of the petitioners that the same be approved in order to vest the title in said lands in the purchaser. It is therefore ordered, considered and adjudged by the court that the said deed be and the same is hereby confirmed and approved, and that a certified copy of this order be made to be recorded in the counties where said lands are located.
